Undertakings

1. We hereby undertake and agree that in consideration of the Insurer agreeing to issue the above Certificates at our request
 - (a) We and all Co-assureds will be bound by the terms of the MLC Extension Clause
 - (b) where any payment by the Association under any such certificate is in respect of war risks, we will indemnify the Insurer to the extent that such payment is recoverable under the Member's P&I war risks policy, or would have been recoverable if the Member had maintained and complied with the terms and conditions of a standard P&I war risks insurance policy,
 - (c) to assign to the Insurer all the rights of the Member under any social security scheme, or other insurance or national fund or other similar arrangement where such scheme, insurance, national fund or arrangement applies in respect of all or any liabilities arising under the MLC Certificates;

- (d) 30 days from a notice to the Flag State of the termination thereof we shall take all necessary steps to remove the Certificates and any copies thereof from the Vessel(s) and return them to the Association.

Declaration

We declare that the particulars and answers are correct and complete in every respect to my knowledge and belief. We agree to accept the policy in the usual form of the Insurer and to pay the premium on due date(s). We consent to the seeking of information from other insurers to check the information provided in this application form and we authorize provision of such information.

Notes

This Application is a prerequisite for issuance of request of the Insured to issue Certificate of Financial Security under Regulation 2.5.2 Standard A2.5.2 and Regulation 4.2 Standard A4.2.1(b) of the Maritime Labour Convention 2006 (as amended) ("MLC Certificates") pursuant to the **Maritime Labour Convention Extension Clause ("MLC Extension Clause")** incorporated in the P&I terms and conditions of the Insurer or endorsed thereto. If P&I cover afforded by the Insurer does not include P&I war risks on the Certificate of insurance, the Insured shall indemnify the Insurer to the extent that such payment is recoverable under any other P&I war risks cover effected by the Insured, or which would have been so recoverable had the Insured maintained and complied with the terms and conditions of a standard P&I war risks insurance policy. The Insured agrees to assign to the Insurer all the right of the Insured under such war risks insurance and against any other party. We authorize the Insurer to notify any Member State if cover is terminated in accordance with any of the terms and conditions of the Policy.
